Sub:-Release of Paddy & Delivery of Rice,be made Easy in Govt Policy-Persuaded.

Respected Sir,

We would like to draw your kind attention towards the problems being faced by the Millers on account of Policy adopted by the Government for Release of Paddy for the purpose of its Milling and the system / pattern framed for Delivery of Rice.

You are aware that, in prevailing / existing system of Rice Delivery the below mentioned procedures are to be followed strictly:-

- 1 To obtain Release Order for Milling purpose.
- 2 Verification Certificate is to be obtained after milling of Paddy
- 3 Delivery Certificate is to be taken for making delivery of Rice
- 4 *To obtain Delivery Schedule / Programme for Rice Delivery.*
- 5 *Delivery of Rice takes place accordingly.*

You shall agree that the aforesaid steps are having the following De-merits:-

- a. We are taking Release Order for Paddy processing / Milling without having any Scheduled /programme for delivery of Rice that causes the following problems.
- b. Millers have to keep Rice in their Godowns for un-certain period, after Milling. Resultantly, the quality of Rice is affected badly and also Loss / Shortage in Quantity incurs.
- c. The Quality of Gunny bags also gets detoriarated involving Monetary Loss.
- d. The Godowns are blocked / jammed. Moreover, the Rice offered /sent for delivery, many a times, being returned claiming inferior quality.

e Rice Millers cannot run their Rice Mill in particular Scheduled Programme ; for which reason extra Loss is to be borne by the Millers in shape of Labour charges.

SYSTEM SUGGESTED FOR PADDY MILLING & DELIVERY OF RICE

Advance Programme for Rice Delivery should be given to the Millers

This Advance Programme / Schedule for Delivery of Rice & Milling of Paddy shall bear the following merits :-

- (i) Quality of Rice can be maintained, when supplied in time.
- (ii) No Loss/Shortage in Quantity can incur.
- (iii) Gunny bags will be safe and No gunny loss can be attained due to friction in handling and mouse-bite.
- (iv) Scheduled Advance Programme of Milling / Processing will also curtail down the labour charges.
- (v) The Government can easily sort out, as to which Mill is supplying/making Delivery of Rice in time. Besides these Govt fund shall also be in safe condition.

So far as the informations required under D.C. is concerned, the same can be easily obtained by asking the Miller to furnish Weekly/ Monthly return in this respect.

We, therefore, request you kindly to persuade the Govt giving stress over the points discussed above and also add something more from your end for the betterment and benefits of Rice Millers of the state as a whole.
