Sub: Release of Custody & Maintenance chg. for KMS 2009-10.

Most respectfully, we enclose copy of letters dt.24.8.12 from M/s. B.D.Udyog and M/s. B.K.Food Products (P) Ltd, Kesinga, Kalahandi submitted to Managing Director, Oscsc Ltd., Bhubaneswar with a copy to your honour and our Association in the above matter. *Sir, it is a long pending but very simple matter and the brief facts are as follows:-*

- 1. That during 2009-10 KMS, M/s. B.D.Udyog and B.K.Food Products (P) Ltd were given paddy for custom milling to the extent of Qtls. 86,934.63 and Qtls.85,312.62 respectively.
- 2. That the entire resultant rice being Qtls.59,115.55 and Qtls.58,012.58 was delivered prior to the expiry of the relevant KMS (i.e. before 30th Sept,2010) without even availing any extended period of delivery. Delivery of CMR due for KMS 2010-11 have also completed by both the millers.
- 3. That a clarification on payment of Custody & Maintenance charges for KMS 2009-10 was issued by OSCSC vide letter No.13212 Dt. 11.7.12 in view of resolution adopted by the Board in the 157th Meeting held on 30.6.2012.
- 4. That vide said clarification, the only conditions imposed were i) Delivery of entire CMR due of KMS 2009-10 by 15.2.2011 and ii) Completion of delivery of CMR due for subsequent KMS 2010-11 too.

In the view of above facts, both the millers namely M/s. B.D.Udyog and M/s. B.K.Food Products (P) Ltd, Kesinga are quite eligible to get payment of pending custody & maintenance charges on paddy for KMS 2009-10.

We therefore, most humbly request your honour *to issue necessary instructions for release of payment to the above millers <u>as well as to other millers</u> <u>of Kalahandi and all other districts who are eligible to get payment</u> as per clarification issued by Oscsc Ltd. vide said letter No.13212 Dt.11.7.12. The matter has already been delayed and an early action in the matter is earnestly requested.*
