Sub: Short notes on resolution adopted at CSO conference on 8.5.12.

It was one of the rarest moments in the History of Rice Milling Industry when representative from Rice Millers Association is invited to give his views as well as suggestions on several issues before the full gathering of Civil Supplies Officers and Accounts Head from all the 30 districts of Odisha at the CSO conference being chaired by Hon'ble Commissioner-cum-Secretary, FSCW Department along with Managing Director, Oscsc Ltd and other senior officials.

We really feel honored and on behalf of all the Rice Millers of Odisha, I thank Hon'ble Commissioner-cum-Secretary and Managing Director, Oscsc Ltd. for giving this privilege to the undersigned.

The short notes and points of discussions are appended herewith. After deliberations made by the undersigned, the points were discussed in detail and the following observations/decisions were made:-

- 1. All CSOs were advised to release and return back the old expired Bank Guarantee to millers. Millers will be asked to furnish fresh Bank Guarantee if any CMR is due for the concerned KMS.
- After completing delivery of paddy to millers against security deposits as per norms specified in the agreement, there is no restriction on further delivery of paddy as per the same norms to the extent of CMR delivered as explained in the agreement as well as in operational guidelines.
- 3. Payment of cost of new gunny bags supplied by the miller for packing of CMR will be made without linking it with insufficient security.
- 4. Even in case of insufficient security, at least payment of milling charges will be allowed as a temporary relief pending finalization of bills at a later stage.
- 5. For calculating requirement of fresh security, pending delivery certificates will also be taken into consideration along with CMR already delivered.

- 6. It was decided that millers will have to submit solvency certificates as per guidelines and sincere efforts should be made to get it as early as possible.
- 7. It was instructed to release pending payment of gunny depreciation at the revised rate for KMS 2010-11, if not yet paid.
- 8. It was decided to release custody & maintenance charges for KMS 2009-10 to all who have completed delivery of due CMR within the KMS or within the extended period allowed by the Govt. Defaulting millers or who have delayed delivery even beyond extended period will not be entitled to get custody & maintenance charges.
- 9. It was decided to refund holding charges to millers who have completed delivery within the KMS. Accordingly, CSOs (including Kalahandi) were advised to settle the matter at the earliest on case to case merit basis.
- 10.CSOs were told to take Head Office approval before engaging millers from other districts to avoid future complications.

It was also clarified by Managing Director that the above decisions will be applicable for all the districts. The above decisions were made in presence of the undersigned who was allowed to leave the conference hall at about 1.00 PM with thanks to the chair.

We very much appreciate the initiative for involving us in various matters to create transparency and a healthy atmosphere. We assure our full co-operation in successful implementation of Government policies from time to time.
