**Sub: Custom Milling operations in 2011-12 and payment of Milling and other Charges thereof.**

We draw your kind attention to letter dated 26.12.2011 of Keonjhar District Rice Millers Association regarding disbursement of Milling Charges (Copy enclosed). It is evident from the said letter that the payment of milling charges etc. to the custom millers are abnormally delayed. Dues of the millers are generally settled on monthly basis by other agencies to the extent of CMR delivered in a particular month. This is being done to help the millers to meet part of their time bound recurring expenses like payment of electricity bills, labour charges etc.

We therefore, suggest that instructions may kindly be issued for payment of at least milling charges on monthly basis while other dues can be settled on quarterly basis. Further, there is no point in with holding the security deposit once the entire equivalent rice is delivered by the custom miller without co-relating it with final settlement of bills. This arrangement will keep the millers in good spirit and will also ensure better participation in procurement process. Hope, this will receive your immediate attention.

Dear Madam,

We would like to bring to your kind notice the following

- 1) We provide custom milling facility for Odisha state and Central Agencies.
- 2) Last year 2010-11 we had finished the processing delivery of all the rice of TDCC by the end of 2<sup>nd</sup> week of April 2011 but the custom milling charges and our security deposit was paid to us in the end of August 2011 after a long perusal at your office.
- 3) All other agencies requiring custom milling are paying us 90% of the milling charges (all charges) at the end of the month of delivery.
- 4) The General Manager, Paddy procurement of TDCC has informed us that this year the milling charges will be paid after completion of the whole year and not on monthly basis.

We request you to pay at least 90% of the milling charges on monthly basis like other agencies as we will not be able to invest such huge amount for milling charges (including all) for such a long period. We hope our stand will be considered positively. We look forward for a favorable response from your side.
