**Highlights of 2012-13 KMS Custom Miller Agreement with Oscsc Ltd.**

1. The first page of the Agreement to be printed on single N. J. Stamp Paper of Rs.20/-.
2. Standard duration of the Agreement will be upto 31<sup>st</sup> December,2013 as against earlier practice of upto only September. (Ref: Clause-8).
3. Security Deposit (Ref: Clause-10): (a) Rs.25,000/- B.G. for Advance Rice Delivery System. (b) B.G. can be furnished only to the extent of 50% of the total security deposit furnished by the miller while balance will be in shape of FDR duly pledged to Dist. Manager, Oscsc Ltd. (c) Miller to furnish security of Rs.1 lakh per MT Rice production capacity in 16 hours (i.e. in 2 shifts of 8 hours). (d) Miller is allowed to furnish less security deposit but delivery of paddy will be restricted to 10, 8, 5 or 3 times of the security as per eligibility criteria.
4. New Mill to be given paddy valued at only 3 times of the security deposit. (Ref: Clause-12).
5. There is no mention of Solvency certificate. However, affidavit of immovable property in the prescribed format (Annx-I) alongwith E.C./Non-E.C. and other documents to be submitted. (Ref: Clause-14).
6. Authorisation of mill staff in proper format (Annx-II) alongwith photographs required. (Ref: Clause-16).
7. Standard time for delivery of rice will continue at 120 days from the date of release of paddy from custody & maintenance account. (Ref: Clause-17).
8. Miller Registration Code No. will be the contract No. to be stenciled on gunny bags. However, FCI may issue separate code No. (Ref: Clause-19).
9. Paddy Mandi Handling exclusively by PACs and loading by Millers. (Ref: Clause-21).
10. Miller to lift paddy on “**AS IS WHERE IS** ” basis. (Ref: Clause-25-iii).

11. Gunny color coding will be “RED” for 2012-13 Kms.(Ref: Clause-25-xvii).
12. New m-Gov. application for Rice Delivery SMS is to be followed. It will be “RBS\_DDMMYY\_PPPPPP\_XXX.XX\_KK\_DD\_NNNN”. There are only 3 alphabets at the beginning which relates to the type of Rice i.e. Raw or Boiled and name of Agency i.e. Oscsc, Nafed, Markfed etc. All other information will be in numerical i.e. 6 digit date, 6 digit rice depot code number, 5 digit rice quantity in quintals and kg (it should not exceed 270 quintals), 2 digit for KMS (12 for 2011-12 and 13 for 2012-13 KMS), 2 digit for district to which paddy belongs (01 for Angul, 02 for Balasore etc.) and 4 digit Rice Acceptance Note Number. *Please note that at present, the system will not accept SMS beyond 15 days from the date of A.C.Note and the same is likely to be reduced to 7 days in future.*
13. Payment: All payments except custody maintenance and gunny depreciation to be released in a phased manner on delivery of 25%, 50% and 75% of the total CMR due for the KMS.
14. List of documents to be submitted with Agreement are given at Annx-VI of the Agreement.
